**MONTHLY PAYMENTS FOR WATER USAGE**

Meter start / end readings will be performed by Churchill County. Monthly meter readings will be provided by the developer at the end of each month. Churchill County will prepare an invoice each month based on the information provided by the developer. Each monthly invoice will include a Customer Service Charge of \$150. Water usage will be charged at the most current rate, as set by the Board of County Commissioners.

All payments are to be made to Churchill County Road Department, 330 N. Broadway Street, Fallon, NV 89406.

**DEPOSIT AND REPAYMENTS**

A security deposit shall be collected for the hydrant meter and valve. Deposit shall be refunded or applied to the customer's final bill upon return of hydrant meter and valve, in like condition to when deposit was made. Customer assumes and shall bear the entire risk of loss, theft,

destruction, or damage to any part of the equipment (“loss or damage”) from any cause whatsoever.

Without prior written consent from Churchill County, customer shall not (a) assign, transfer, pledge, or otherwise dispose of this agreement, the equipment, or any interest therein or (b) sublet or lend the equipment or permit it to be used by anyone other than the customer or customer’s employees.

At customer’s own risk, customer shall use or permit the use of the equipment solely at the location specified in this agreement, and such equipment shall not be moved without prior written consent by Churchill County.

In witness whereof, each party has caused this agreement to be executed as directed by the Churchill County Board of Commissioners, Churchill County Water Service Ordinance, Article 4.4 (*attached*).

\_\_\_\_\_ **When utilizing the hydrant, the hydrant valve must be completely open, or completely closed. Failure to do so will cause major damage to the hydrant.**

**13.04.330: CHARGES FOR CONSTRUCTION WATER is amended as follows:**

A. These charges apply to metered use of water during development and construction within Churchill County.

1. Application for service must be completed at Churchill County Road Department.
2. Deposit for hydrant meter and valve of one thousand five hundred dollars (\$1,500.00). Deposit will be refunded or applied to the customer's final bill upon return of hydrant meter and valve in like condition to when deposit was paid.
3. The contractor will be responsible for construction of temporary truck fills and appropriate backflow prevention assembly consistent with the County's conditions of service. This setup will require inspection, meter reading, and backflow prevention assembly testing prior to activation.
4. Monthly customer service charge of one hundred fifty dollars (\$150.00) each month, regardless of gallons used.
5. Water usage charge of two dollars sixty cents (\$2.60) per one thousand (1,000) gallons of water used each month. Meter will be read monthly.
6. Installation of meter will be performed by Churchill County road department at designated fire hydrant and locked to the hydrant. Contractor is responsible for installing and maintaining a lock on the valve.
7. Contractor will be responsible for any damage caused by improper use or handling of fire hydrant and metering device.
8. Meter readings will be performed by Churchill County representative and billed for on a monthly basis. (Bill 2007-D, 2007)
